We also met with Congresswoman Jaime Herrera Beutler (please see Roy's write up in the Federal Legislative Affairs section of the newsletter). Although armed with excellent point papers provided by MOAA, I was still a little uncertain about the importance of our message to her. After all, we were basically thanking her for voting for HR 4435 (FY 2015 Def Auth Bill) thus rejecting the Administration's proposed cuts.

When I asked her how we could help her, the answer why we were meeting became crystal clear to me. Congresswoman Herrera Beutler said, "provide (accurate) information." She said they only know what they are told (and they don't have much time to read--at least not to the extent they would like to). It IS important to share and pass along CORRECT information. So often, the national media "gets it wrong" (my words) and therefore, it is up to us to give our legislators and the local media (via interviews and letters to the editor) the correct information. Roy & I were pleased to know we could help and make a difference.

We continued our on-going dialogue with the IRS regarding our 501(c) 19 status as a Veterans nonprofit organization. In fact, this is why we need every members' dates of military service. If you have not done so yet, please send them to me ASAP at MOAACRCpresident@comcast.net. I anticipate being asked for this information soon (the IRS just asked us for a copy of our Articles of Incorporation).

Our membership service team will be contacting members by telephone in early September to update our rosters and ask your input on a few items. We would like to know if you receive the MOAA legislative alerts and if you do, how frequently are you able to hit "send" on the suggested message?

You will see an article in this newsletter from the National MOAA Auxiliary Member Advisory Committee (AMAC) announcing that auxiliary members have full voting rights in national MOAA elections and encouraging chapters to do the same. The Columbia River Chapter is proud that we actually gave full voting rights to auxiliary members and changed our by-laws to reflect this before national MOAA did. We have also invited auxiliary members to participate as members of the board. We have two very important positions opening on the board in February 2015 and we would be delighted to have auxiliary members consider these.

We have a great lineup for you this fall starting with our kickoff barbecue 3:00 PM Sunday, September 21st at the home of John Donnelly. This is an opportunity to chat with other members in an informal social setting. We supply the meat and beverages and ask you to bring a potluck salad, vegetable or dessert. ## FLU IMMUNIZATION REMINDER: submitted by Roger DeRoos, Ret. USPHS

It is time to start thinking about getting your annual flu immunization. I receive several email health-related newsletters, and the recent one from the Centers for Disease Control (CDC) included the most up-to-date advisories for flu immunizations. There are two new advisories; one for the nasal administered, live attenuated influenza vaccine (called LAIV) which is sprayed into the nostrils, and the other for the "inactivated" or "recombinant" vaccine, which is administered via injection. The nasal vaccine is recommended for ages 2 to 49.

So those of us who are more advanced in age will need to continue with the injectable version. The link to the CDC "Vaccine Information Statement" update is provided below. The links to the two statements for influenza are provided in the "Routine" section about half way down the page. Perhaps you will want to pass copies on to some family and friends for their benefit.

Note that it takes about 2 weeks for protection to develop after the vaccination, and that protection lasts several months to a year.

The LAIV version (nasal) protects against 4 different influenza viruses. You are getting a live, attenuated influenza vaccine (called LAIV), which is sprayed into the nose. "Attenuated" means weakened. The viruses in the vaccine have been weakened so they won't give you the flu. In contrast, an injectable flu vaccine, is either an "inactivated" or "recombinant" vaccine. This vaccine does not contain any live influenza virus. They are given by injection with a needle, and often called the "flu shot".

Even though flu vaccine will not prevent all cases of flu, it is the best defense against the disease.

In addition, the garden will promote self-reliance, physical activity, social interaction, and contribute to the health and well-being of Veterans. Product from this garden will be donated to Veterans through the Clark County Veterans Community Center.

The garden will be on 2 fenced acres at the Mabry Center (8101 NE 117th Ave) and include a 96' green house, raised garden beds that are wheelchair accessible, used nursery equipment, a fruit orchard, and four 40'x60' garden spaces:

Funding will be used to build raised garden beds that are wheelchair accessible, stable pathways, and other gardening supplies.

MOAA's auxiliary members are the survivors of deceased MOAA members or the survivors of deceased individuals who, if living, would be eligible for MOAA membership. As of a vote by MOAA members in August 2012, auxiliary members now have voting rights.

For the first time, an auxiliary member will hold a position on the MOAA board of directors for a six-year term of office. His or her job will be as spokesperson for all auxiliary members and to represent the interests and issues of surviving spouses on the board. The ballot is on the cover-wrap of the August 2014 edition of the *Military Officer*. Auxiliary members now may be eligible for leadership roles in councils and chapters. Some chapters already have begun using the talents of their auxiliary members on their boards, not just as auxiliary liaisons but also as chapter presidents, vice presidents, secretaries, newsletter editors, and more.

Having experienced military life of service and sacrifice, auxiliary members add value to chapters and councils. As military spouses, they have many experiences unique to the military lifestyle. They have left their hometowns and established new homes at every duty station, moved often and usually alone, served the role of single parents during deployments before Skype and email existed. In addition, they have been chauffeurs, team moms, scout leaders, PTA officers and members, event planners, hosts, fundraisers for military officers' spouses' clubs and other organizations, and committee chairs — sometimes all while holding jobs of their own. Auxiliary members are sources of untapped talent.

Auxiliary members should consider volunteering for leadership positions within local chapters, and chapter leaders should consider inviting their auxiliary members to participate in their chapters. Chapters with active auxiliary members tend to be more successful. Consider including your auxiliary members when considering new board positions. They will increase your official chapter membership while providing new ideas, leadership opportunities for your chapter or council.

#### Legislative Affairs: by Roy Korkalo

## Visit With U.S. Representative Jaime Herrera Beutler

David Casteel (President, MOAA Columbia River Chapter) and Roy Korkalo (Chapter Legislative Chair) recently visited Congresswoman Herrera Beutler in her local Vancouver office.

It was a mutually productive meeting with free exchange of information, ideas and goals.

We discussed her welcomed support of HR 4435 (FY2015 Defense Authorization Bill) that rejected the reduction of the 1.8% pay raise due our military as well as rejecting the 5% increase in out-of-pocket BAH (Basic Allowance for Housing) costs. HR 4435 also prohibited use of funds to close commissaries and additional base closures.

We discussed the interim report of the MCRMC (Military Compensation and Retirement Modernization Commission). The Commission report indicates that 30% of the defense budget has gone to military personnel and health costs continuously for 20 years and has always been affordable. Critics are saying 50% and costs are out of control.

Now, we must follow the Senate's actions as they reconvene and respond with MOAA's suggested communications to voice our opinions in preventing reduction in military benefits.

David and I have since talked to the local offices of Senators Murray and Cantwell and will soon visit to discuss ongoing legislative issues affecting military personnel.



## Another Look at the Military Retirement System

Articles in a number of military oriented publications and correspondence (Military Times, MOAA, Army Times) recently outlined Pentagon proposals for a long-term, far reaching change to the military retirement system.

The proposed options will be considered by a military compensation committee before its final report that is due in February 2015. Congress must approve any changes to the current system. The Pentagon's proposals are not formal recommendations and are not in its 2015 budget.

Current military personnel are not expected to be affected, but may have the choice to participate. This may be to the benefit of those who do not plan to continue a career to retirement. Note that now, less than 20 percent of military personnel stay in long enough to see any retirement benefit. And then, many of those who do retire are young and talented and pursue a second career in the civilian sector. The new proposals may improve retention.

Under the various proposals, the service member would have more money up-front to transition into a second career after leaving the military.

The plans, (Thrift Savings, 12-year retention payment, and the 20-plus year transition pay), would cost DoD more up-front. But, studies show a five to fifteen percent savings after being in effect for 30 years.

Reserve service members would also see changes. One option would still require reservists to reach age 60 before receiving retired pay. Another option would allow partial pay upon retirement and then full-retired pay at retirement age of 62. There would be differences in determining pay between retiring reservists who spent time on active duty and those who did not.

We will see a lot of comments and opinions about the proposals during the rest of 2014. Now we wait until February 2015 to see what the compensation committee report recommends.

#### **MOAA Legislative Affairs Webinar**

MOAA recently held a computer based instructional seminar (WEBINAR) covering interactions between MOAA chapters and U.S. Congressional Members. It was enjoyable, informative and very well presented. Some highlights included a description of MOAA's methods of contacting our elected officials. Currently, MOAA has frequent contact with about 77% of U.S. Congressional Members who represent Congressional Districts. MOAA National or local Chapter Presidents and Legislative **Affairs** Representatives are active in making these contacts.

The goal is 100%. Methods of contact include:

1. "Storming the Hill" each spring, with MOAA representatives personally visit Senators and Representatives in Washington, D.C.

- 2. MOAA does "Score Cards" showing voting records of Senators and Representatives.
- 3. Chapter personnel meet in August with Members at their local home offices during annual recess.
- 4. Regional symposiums in September at the State level.

Throughout the year, grassroots vehicles are in motion.

## **Disability Offset**

Currently the majority of military retirees with disability benefits forfeit, dollar for dollar, retired pay to receive the VA disability pay. MOAA has always been against this offset. Here is MOAA's position as published in their current Annual Report.

MOAA is committed to ending the disability offset for all disabled retirees. We believe strongly in the principle that career military members earn their retired pay by service alone, and that those unfortunate enough to suffer a service-caused disability in the progress should have any VA disability compensation from the VA added to, not subtracted from their service-earned military retired pay. In the case of members forced into medical retirement before 20 years of service, their serviceearned retired pay should be vested at the rate of 2.5% times years of service times the applicable pay base. There should be no distinction between disabled for combat-vs. non-combat-related causes, as the impact on their quality of life and future earning power is the same in either case.

Senate bill S 234 and House bill HR 333 support this change.
