Agent Orange & VA Benefits by Sharon DeVaney

After my husband died unexpectedly from a heart attack and the shock wore off, I began to learn about Agent Orange and the part it might have played in my husband's death. Like many veterans his age, he served in Vietnam and I thought he might have been exposed to Agent Orange. He was a Forward Air Controller and flew small planes over combat areas from 1967-1968. After he returned from Vietnam, he was assigned to Strategic Air Command as a B-52 pilot. During 1970-1971, his temporary duty assignments took him from Minot AFB in North Dakota to Thailand where he flew bombing runs over the war zone.

We had a speaker from the VA at one of our monthly MOAA luncheons. He talked about Dependency and Indemnity Compensation (DIC). He wasn't specific about who was eligible, but it seemed my husband's death might qualify me for DIC. I already had met with personnel at the VA soon after my husband's death so I would understand my benefits. I was disappointed with the reception and the information I received. I was reluctant to return to the VA to learn more about DIC. Then I met someone who was actively encouraging widows and widowers to attempt to

find out about the benefits their spouses had earned through their service.

I used the Internet to learn more about Agent Orange < http://tinyurl.com/qhmqnvo > and found a list of presumptive diseases on the VA website. I realized the cause of death on my husband's death certificate was on the VA's list of presumptive conditions, which includes ischemic heart disease, hairy cell and other B-cell leukemia, Parkinson's disease, prostate cancer, chronic lymphocytic leukemia, Hodgkin's disease, Non-Hodgkin's lymphoma, or multiple myeloma.

I made another appointment with the local VA. Fortunately, my appointment was with someone who was very understanding. I was asked to bring all paperwork that showed my husband had been stationed in Vietnam sometime between Jan. 9, 1962, and May 7, 1975. I brought a stack of papers, including a copy of the Red Cross telegram notifying my husband of our son's birth in May 1968. The VA representative reviewed my paperwork and prepared an application. A few months later, I was awarded DIC.

If your spouse or a family member served in Vietnam and he or she has been diagnosed with one of the presumptive diseases, be sure to learn about possible benefits.

For more in-depth information regarding DIC eligibility and the application process, visit the DIC < http://tinyurl.com/nwam4a4 > section of the VA's website. If you believe you are eligible for DIC after reading through the information, we suggest you contact a local accredited Veterans Service Organization (VSO) < http://www.va.gov/vso/ > to assist you in filing a claim.

Legislative Affairs: by Rod Williams

Since returning from their summer break both the Senate and House passed the defense bill. As of this writing it was awaiting Presidential signature or veto. By the time you read this we may know if President **Obama** exercised his veto to counter action by Congress adding \$38 billion in a supplemental wartime account exempt from budget caps

On Oct. 1, MOAA President Vice Adm. Norb Ryan, USN (Ret.) wrote the president urging against a veto. "As much as we disagree with some of the provisions," Ryan said, "the fact is that we are still a nation at war, and this legislation is vital to fulfilling wartime requirements." On the surface it might appear that a veto might give chance to redress some of the provisions MOAA opposed, however, a veto would not reopen any of the things MOAA is concerned about in the bill. We lost those fights in the Armed Services committees, with compromises grudgingly reached in the interest of getting a bill passed. Our National MOAA representatives opine there is zero possibility of any of those things being renegotiated in a Hill environment that is focused almost exclusively on budget issues, such as, raising the debt ceiling, figuring out the entire government budget, and avoiding a federal shutdown by funding it through a continuing resolution or some other measure.

MOAA has taken the position that the best option is for the President to sign the defense bill with the \$38 billion in contingency money now, keep the White House and Congress focused on negotiations

on the already huge challenges for the remaining legislative year, and push our remaining legislative agenda in 2016.

In September President Obama used his executive authority to cap military pay for the third consecutive year. In 2014 and 2015, pay raises were capped at 1 percent. For 2016 pay raises will be capped at 1.3 percent, instead of the 2.3 percent raise called for by law. The troops' last four raises averaged less than 1.4 percent, with the FY14 and FY15 pay raises being the lowest in 50 years. In announcing the cap, President Obama said he is, "strongly committed to supporting our uniformed service members, who have made such great contributions to our Nation over the past decade of war." However, he insisted that this move is necessary to, "maintain efforts to keep our Nation on a sustainable fiscal course." Many of us recall the pay caps during the 1980's and 90's, which created a 13.5 percent pay gap caused recruitment and retention to suffer. It looks like we are about to repeat history.

As always, I encourage you to stay informed and act. Go to the "Take Action" tab at <u>www.moaa.org</u> and stay on top of the hot topics. Exercise your voice and email to our two Senators and our Representative. We owe it to those who have served and are still serving to speak up and not be a silent constituency.


