The Veterans Stand Down brings community public services and assistance agencies together in one place for a day to help veterans and their families. It links at risk veterans with housing, health, employment services, and other community resource specialists with a goal of reintegrating such veterans into the community. Expect to hear more about this at we get closer to the day. We will be asking for volunteers to help set up, serve, and break down.

The chapter legislative affairs team has been busy at both national and state levels. Dave Casteel, as President of Washington State Council of Chapters, and Buck Marr took part in the MOAA Advocacy in Action in April. They provided a detailed update at the May membership meeting. Buck's latest article in the legislative section of this newsletter is a must read. You should also know, the "Respect for Grieving Military Families Act" (H.R.3232, S.1588) was recently introduced in both houses. This important legislation aims to prevent the Department of Defense from reclaiming the benefits of deceased military retirees while their families are still in mourning. Such an action could deplete bank accounts of any remaining funds, regardless of whether they were retirement payments or sourced from elsewhere. The bill proposes a gradual repayment over 12 months instead of a one-time withdrawal, also granting the Secretary of Defense the option to forgive the overpayment. We urge members to express their views on this issue and encourage moving it forward through the legislative process.

Federal Legislative Update: by Buck Marr

Lately, the U.S. form of governance resembles a Disney E-Ticket roller coaster ride. Finger pointing has evolved into a major league sport. But do not despair, with loud squabbling and frequent uncivil public pronouncements, our elected officials crafted legislation avoiding debt default and budgetary calamity well ahead of the August 2011 partisan wrangling which brought the country to the brink of default with a vote coming hours before the debt default deadline.

Raising the debt ceiling used to be a routine Congressional action. Dispensing with hyperbole, this recent impasse could be described as "politics as usual." The vote which formerly was routine has now become an opportunity to include party priorities. And that brings us to a critical advocacy juncture. I daresay that most advocacy warriors had definite feelings about one side or another of the debt ceiling debate. Picking sides is common for this country, but doing so misses the point for MOAA-ites. Whatever the outcome of the debt debate, one thing is historically a sure thing; the debate and its outcome WILL affect legislation during the remainder of the 118th Congress. Bills will be influenced directly or indirectly by what happened with the debt ceiling agreement. Let's be prepared by refreshing ourselves regarding a few MOAA endorsed advocacy opportunities.

H.R. 2537 BAH Restoration Act. (Strickland WA-10) An Advocates in Action issue proposing to reset the Basic Allowance for Housing to 100%. It is receiving bipartisan support with 36 Democrat and 14 Republican cosponsors. S.4562 is the Senate companion bill introduced by Sen. Warnock in the 117th Congress.

TRICARE Pharmacy Network. MOAA advocates for language in the FY24 National Defense Authorization Act directing the Defense Health Agency do an analysis of the impact on pharmacy access to vulnerable populations resulting from the cost-cutting measures which cut a large number of in network pharmacies.



S.344 & H.R. 1282 Major Richard Star Act. These Bills fell just short of passage in the 117th Congress. They propose concurrent receipt of retired pay and disability compensation for combat-disabled retirees with less than 20 years of service. 314 cosponsors in the House. S.344 is the Senate companion with 65 cosponsors.



18 May 2023: MGEN Buck Marr USAF (ret) updated Chapter Members on Federal legislative affairs.

Attached to May's issue of The Military Officer are easy to detach and mail post cards to our two WA Senators and our District's Representative. PLEASE sign them and mail them. They ask our legislators to support:

H.R. 1413 Expanding America's National Cemetery Act of 2023 (McClain R-MI). This bill proposes the expansion of Arlington National Cemetery (ANC). It preserves interment for veterans who will lose their eligibility if the planned reduction moves forward. This simply cannot happen to people who have built their end-of-life plans around an eligibility promise. This is a must piece of advocacy. 46 cosponsors evenly split between the parties.

S.495 Expanding Veterans' Options for Long Term Care Act (Tester D-MT) Five Senate cosponsors including Murray. House companion H.R. 1815 (Slotkin D-MI) with eight cosponsors including Larsen (WA-2). Authorizes the VA to launch a pilot program to analyze the effectiveness of paying for assisted living services.

Federal Legislative Update continued

S.141 Elizabeth Dole Home Act and H.R. 542 House companion Bill (Tester D-MT and Moran R-KS). 18 Senate cosponsors and 48 House cosponsors including DelBene, Kilmer, Strickland, and Larsen from WA. To improve existing VA programs for home and community-based veteran services. S.622 Helping Heroes Act introduced by Sen Murray (WA) is very similar and worthy of your review.

Two final suggestions on important proposals for your review:

H.R. 1763 Military Family Nutrition Act (Panetta D-CA) with 21 cosponsors including Strickland, Rodgers, and Kilmer. Amends the Food and Nutrition Act (2008) to exclude housing allowances from income computation for purposes of determining SNAP eligibility.

H.R. 1764 Military Food Security Act (Panetta D-CA and Strickland D-WA) with 13 cosponsors including Rodgers from WA. It proposes to exclude housing allowances from gross household income for purposes of determining basic needs allowance eligibility.

The Bottom Line: Keep up your advocacy regardless of the debt ceiling solution.

Being well read and knowledgeable on the issues is not good enough anymore; we must be continually communicating with our national legislators to be effective advocates.

Attention: Surviving Spouses!

The information below was written by the Administrator of the "MOAA SURVIVING SPOUSES AND FRIENDS FACEBOOK GROUP. This applies to only those that are receiving the Survivors Benefit Plan (SBP) and Dependency and Indemnity Compensation (DIC).

If you receive a new annuitant statement from DFAS with a change in the tax deduction.

PLEASE READ.

Because the <u>WIDOWS TAX OFFSET</u> has been eliminated, and Survivors Benefit Plan (SBP) is taxable federally and in some states, Department of Finance and Assenting Services (DFAS) is automatically deducting taxes. If this withholding is incorrect, then do one of the below 3 items.

THE BACK OF THE LETTER STATES THAT IF YOU WANT TO CHANGE INFORMATION ON YOUR ANNUITY STATEMENT OR HAVE A QUESTION ABOUT YOUR ANNUITY, YOUR TAX WITHHOLDING, THERE ARE 3 WAYS TO DO IT.

- 1. Call DFAS 800-321-1080
- 2. Write to DFAS. instructions on the back of the letter
- 3. myPay. https://.myPay.dfas.mil. Use your Login and password. If you have not set this up yet. Use your social security number and PIN.

Columbia River MOAA Foundation (CRMF) by Dave Casteel CRMF President

Special thanks goes out to the 26 members who made a donation to either the Scholarship fund or the Support the Troops (STT) fund in response to the first-of-the-year dues letter. This broke down to \$1,895 for our scholarship fund and \$2,039 for our STT fund, for a total of \$3,934.

Because many of you gave generously (and some annually) last fall, we were able to support both our \$1,500 (plus \$75 admin fee) annual WSU-V scholarship AND pay two year's (\$4,160) towards fully endowing the Colonel Paul S. and Ivadell M. Crosby Columbia River MOAA Foundation Scholarship. This leaves us with only one payment of \$2,080 remaining next year to fully endow the WSUV scholarship! Our Clark endowment distribution again covered our three \$1,000 scholarships there. As tuition continues to rise, we plan to reevaluate the Clark scholarship amounts and consider adjusting them upward, especially since our endowment there has been covering our costs the last two years.

We made several donations this spring from our STT fund. One was to the Clark College Veterans Center for Excellence in the amount of \$500 during the Penguin GIVE appeal. This was especially beneficial to our veterans there since the gift was matched 100%! Under **Megan Anderson**'s guidance, as the Veteran's Educational Planner (the Center's lead person), they will use the fund to assist student veterans as needed. Some of the needs include textbooks, childcare cost reimbursement (so they can attend class), food, gas, etcetera—all critical needs to enable our veterans to pursue a degree. As you may know, even if they are receiving educational funds from a GI bill, the funds don't cover all their costs, and the funds notoriously lag the time when payments are due to the college.

Another STT fund donation we made this spring was \$500 in the form of an Amazon gift card to Vancouver Fisher House. While they still do not have a full-time manager on board (as of early May), the assistant and acting manager, **Dawn Schultz**, who has been there since the Fisher House opened seven years ago, said this would be the most helpful since there are no administrative fees to the card and it can be used to order meals for guests, among other necessities. It is always a pleasure working with Dawn—she has a heart of gold.

We also donated \$500 to the Transplant lodge on the Vancouver VA campus in the form of a VISA gift card, which they said would best help with their needs. They use the card for things such as transportation to and from the Portland VA hospital when the shuttle is no longer running (after hours and on weekends), Uber to/from PDX, purchasing food for use in the veterans' communal kitchen, etcetera. We will miss working with **Michelle Swanson** who has moved on to another position. She was always so cheerful and very thankful for our gifts.

In May we paid \$500 towards the repair of a broken garage door (and with **Terry Babin's** help, we collaborated with the Marine Corps League who paid the remainder of the bill) of an 88 ½ year old Marine corps veteran who was stationed at Camp Lejeune in the 1950s. We were successful in getting him moved to a contract VA hospice facility in Camas at the end of May. The new location is a much shorter drive for his wife. Although very frail, she is still able to drive to sit with him every day. (Side note. He was not enrolled VA healthcare, so it took two full months to get him approved for VA hospice and the move. We learned that although VA has a hospice facility on the Vancouver campus, patients can only be sent there if they come directly from the VA hospital in Portland!).

In July, we will again be making an annual \$750 donation from our STT fund to the Clark County Veterans Assistance Center (CCVAC) as an Bronze level supporter. As you may know, they disburse Clark County funds to veterans, but the requirements for fund eligibility are extremely strict and restrictive which means most homeless veterans do not quality. Using donations such as ours, the CCVAC can provide daily sack meals for breakfast and lunch and for other items such as socks, underwear, women's items, sleeping bags, tarps, etcetera that are not available using county funds. Their major expense is the annual Stand Down (September 29th this year) made possible by private and corporate donations. Last year it cost \$30,000! The chapter will help by purchasing food and serving meals at this year's Stand Down using MOAA Community Grant funds. Please SAVE the DATE.

One of our ongoing challenges is keeping the relationships renewed and learning of new needs whether at the Fisher House, the Transplant lodge, CCVAC, our veterans centers on Clark College or WSU-V, or just helping individual veterans.

What we are able to do for veterans in our community is directly due to YOUR continuing generosity. Thank <u>YOU</u> for allowing us to help fellow veterans using your generous donations.

Leah Davis, Surviving Spouse Representative, and I appreciate the interest and large attendance at the May 18th Chapter meeting's Personal Affairs presentation.


One subtopic not covered during the presentation was recommendations on attachments to your written end of life and disposition of remains instructions:

 Include a copy of the Columbia River Chapter's Checklist for death of a member or surviving spouse. Both checklists have been updated and are provided starting on pg. 11 below in this Newsletter, following the Calendar.

- Download (or otherwise obtain) a copy of the Veteran Administration's Claim for Standard Government Headstone or Marker (VA Form 40-1330), and complete blocks # 1-6, 8-10A, and 11A-18. This will help the next of kin know what you want on your headstone or marker even if a private headstone or marker is purchased.
- Include a list of "Gifts of Tangible Personal Property," when applicable, such as memorabilia and personal items (jewelry, furnishings, collections, etc.).

Also provided starting on pg. 11 below in this Newsletter, following the Calendar is a copy of the "Personal Affairs Documentation Tips" handed out to the Chapter meeting attendees.

Treasurer's Report: Chapter Member Dues Status by Larry DeVries



CRC paid dues for 2023 is below 2022 levels. We raised the 2023 budget expectation as we targeted members in arrears for dues. Less than half of registered CRC members have paid 2023 dues.

PERSONAL AFFAIRS DOCUMENTATION TIPS

Make sure you have and quickly available the following:

- Columbia River Chapter and MOAA, Checklists.
- Any applicable Power of Attorney (e.g., Health Care Power of Attorney).
- Any Living Will or Advance Medical Directive.
- Any organ donor information and instructions.
- Health and Long-Term Care insurance policies.
- <u>All DD Form-214s for both regular and reserve service encompassing All service time.</u>
- Funeral and interment instructions and prepaid services.
- Location of Last Will and Testament.
- All marriage certificates, divorce or death decrees, and birth and death certificates for prior marriages of both member and current spouse.
- Birth and death certificates (and adoption papers) if applicable for children.
- Life insurance policies.

Review and ensure the following are also available:

- Beneficiary designations are current—particularly old insurance policies (e.g., Army & Air Force Mutual Aid Association).
- Documentation for disposition of property outside the probate process.
- All titles (e.g., home, secondary properties, vehicles, boats, etc.)
- Documentation of disability determinations by Service and/or Veterans Administrations.
- Copies of Service Record and medical/dental records.
- Documentation for Trusts (e.g., Revocable Living Trust)
- Passwords and safe deposit box information and keys.
- Information on all savings and checkbook accounts.
- Information on all Individual Retirement Accounts, brokerage accounts, and other financial assets
- Information on "Survivor Contingency Bank Account."
- SBP information.
- Copy of latest "Retiree Account Statement" form DFAS-CL 7220/148.

- # 6: Priority should be life insurance and financial institutions which provide quick access to funds. Also:
 - Notification to DFAS (see Note # 4) automatically initiates applications for any unpaid retirement and the Survivors
 Benefit Plan (SBP) if the deceased retiree elected to participate in the Plan. The retiree's current year "Retiree
 Account Statement," DFAS-CL 7220/148, list the coverage for the SBP and the arrears of pay beneficiary(ies).
 - Arrangements for an appointment with the Veterans Services Office (VSO) for advice and application assistance for possible VA benefits should be made regardless of whether or not the deceased was drawing VA benefits before death.
