

Federal Legislative Update: by Bob McFarlin

As the summer draws to a close so does this session of congress. Congress will be in session September 9-27. If we are to have an impact on legislation in the short term we need to act now.

The latest MOAA magazine and on-line newsletter provide pre-addressed letters for you to send to your congressional representatives. Be sure to put our chapter number, WA 01, on the letters. Letters provided ask for action to pass the Richard Star Act, Restoring the Basic Allowance for Housing, and resolving the difference between the House version of the Defense Authorization Act and the Senate version so that our junior enlisted members can receive the appropriate pay raise.

Even if you don't get your letters in before September 27, send them anyway. Let them know you still care about these issues. They will be back in session after the election.

Here is some newly received information. MOAA national says we have 103 chapter members. Of those only 34 of us have registered to be advocates and in total since the beginning of the year we have sent only 126 letters to our legislators. We should be able to do better than that.

To <u>keep on serving</u> go to the MOAA website and sign up to be an advocate then take the next step and contact your elected representatives frequently. Here is **Caitlin Harrington** from **Sen Murray's** office whom we visited on August 19.

Washington State Legislative Affairs by Dave Casteel

While all the media focus is on the national elections, we need to remember that a great many (if not most) of the laws passed that affect us are passed at the state level.

There are so many bills introduced at the state and federal level that it is almost impossible to keep up. At the federal level, we have MOAA to advise us of pertinent veteran-related bills and issues. At the state level, we have the Veterans Legislative Coalition (VLC) advising us (of which MOAA has a representative). The VLC meets monthly starting in August planning for the next legislative session which in 2025 begins on Monday, January 13, 2025 and is expected to last 105 days, ending on Sunday, April 27, 2025. Once the legislature is in session, the VLC meets weekly reviewing and testifying on veterans-related bills. Last session there were 12 veteran-related bills signed by the Governor which was noteworthy during the nonbudget 60-day short session!

The VLC hosts an informal welcome standup "luncheon" in the Columbia Room in the State Capitol Building at the beginning of each legislative session. It is a chance for VLC members to briefly meet and chat with Legislators and their legislative assistants. I plan to attend this session again.

So, how does a person keep of track of all these bills? Bills tend to be a very fast-moving target and difficult to for us to share widely and quickly. However, the Washington Department of Veterans Affairs (WDVA), publishes a weekly list of all veteran-related bills during session by subscribing at https://public.govdelivery.com/accounts/WADVA/subscriber/new. If this doesn't' work, you can contact the WDVA Legislative coordinator at WDVA directly at heidia@dva.wa.gov. Once you subscribe you should receive weekly updates. You can also visit https://app.leg.wa.gov/billinfo/ for more detailed bill information by bill number and importantly, comment on a bill.

In each chapter newsletter we publish all the federal and state legislative contact names and addresses for your convenience. We will update it again after the general election in November.



Columbia River MOAA Foundation (CRMF) Update by Dave Casteel CRMF President

Hope your summer was enjoyable, but boy, it sure went by fast!

Foundation activity was quiet but is picking up quickly in September. It started with **Frank Hill** and I visiting the Clark County Veterans Assistance Center on Sep 3 donating \$1,000 towards the annual veterans Stand Down. The Stand Down will be held at the Armed Forces Reserve Center on Sep 27 where we will also be volunteering as greeters.

Next, we have the annual Scholarship Fundraising BBQ at **Roger Rosenberry's** home on September 15, and really hope you can attend, but understand many of you are still traveling (we were last year at this time). We will certainly miss seeing you if you can't attend.

If you are unable to attend and would like to make a donation to the Scholarship fund (or the Support the Troops Fund (STT) if you prefer) you can mail a check to: Columbia River MOAA Foundation (CRMF), PO Box 1872, Vancouver, WA 98668. As many of you have already done, we also accept Qualified Charitable Distributions (QCDs) from your Required Minium Distribution mailed to the same address. Donating via QCD is a win-win. You have to take a RMD anyway, and if all or part of it is a QCD, the amount you donate via QCD reduces your Adjusted Gross Income dollar for dollar! The good news is you do not have to itemize

to reduce your AGI this way. If you want to donate via a QCD, we recommend you do not wait until December as some financial firms take <u>several</u> weeks (especially at year's end) to send out a check (which needs to be received and cashed by the charity NLT Dec 31 to count for same year tax reduction).

If you would like to donate appreciated stock held long term, we also have a no-fee (to the CRMF) Vanguard brokerage account. This can also be a winwin. First, you potentially eliminate the capital gains tax you would incur if you sold the assets yourself and donated the proceeds, which may increase the amount available for our charity by up to 20%. Second, if you itemize, you may claim a fair market value charitable deduction for the tax year in which the gift is made. Please contact me if you are interested in this option so I can give you all the required information your financial advisor will need. My phone and e-mail are on the front page of the newsletter.

A really easy way to support the CRMF scholarship and STT funds is to connect your Fred Rewards card to the CRMF. That way, each time you shop and enter your phone number, a portion of your payment will be sent to the CMRF for which we receive a quarterly check. We thank the 12 families in the chapter who now do this for an on-going stream of donations.

Thank you for your great support of the CRMF. It is because of your support that we are able to support active duty and veterans. Please know, we are always looking for ways to help active-duty families and individual veterans.

Even when you think you are totally prepared there will be times when "you don't know, what you don't know". It is very important to try and get as much information you possibly can.

A week or so ago, as a Surviving Spouse Liaison for our Chapter, I was invited to participate in a National MOAA Webinar, led by **Paul Frost**, Program Director, Transition Center, that focused on "Preparing a Spouse or Family Member for Survivorship".
