companionship. And as always, our

thanks giving for our many blessings and remembrance of the less fortunate.

Before my deeper involvement in CRC, I helped deliver Thanksgiving meals to remoter locations in

Clark and Skamania counties. This year, I was offered a home meal delivery myself but declined. Instead, our stateside family came to Camas.

After a week in Trauma Center, nearly 2 months in a Rehabilitation Center, and now a few weeks in Home Care, this year focused on a new blessing: living at home! Zoom brought the German based family members into our virtual gathering.

Thanksgiving like Day, Independence Day, are great American unique holidays. Both days often were NATO work days and/or school days and German celebration typically moved to the following Saturday. Luckily, I could always purchase a Butterball Turkey (and trimmings) at a nearby U.S.

Army Commissary, although cooking a challenge given the typical size of European ovens. The most practical method preparing a large Turkey became barbecuing on a covered Weber Grill in the backyard regardless of weather.

When **Annette** reported her first American foreign exchange student at her German high school (called a Gymnasium), we took the initiative to deliver the U. S.

produce to the student's adapted European family. Over the years, "Operation Butterball" expanded to families in nearby schools across three borders (Germany, Holland and Belgium) where American kids had share the unique U.S.

opportunity to tradition.

AAFES become a sponsor. **Annette** created a recipe checklist to follow in the 4 languages with special care taken to convert temperatures and oven measurements before Turkeys ordered. **Annette** also described the American Thanksgiving story in 4 languages.

At peak, we assisted 13 families before "Operation Butterball" terminated (I lost Commissary privileges with NATO retirement). Good memories of the effort to bring a little Americana into the lives of American kids and their temporary European families.

We met some great American kids over the years

often struggling with their first holiday away from home. And, we also had a French high student live with us while attending the German school where Annette taught. Our son, Nikolai (Nick), went to Brittany (on French



Atlantic Coast) and adapted to the French traditions.

Bringing the topic back to our own community, an important reminder of how much our chapter does locally to assist Veterans and their families. Another successful "Stand-down" at the East Vancouver Army Reserve Center, the Veterans Day Parade at Fort Vancouver, assistance to support centers (like Fisher House) helping out-of-town families of Veterans while getting care at our regional VA hospital, and youth groups like Junior ROTC, Civil Air Patrol, Sea Scouts, and Sea Cadets. And our Christmas Party recognizes the outstanding scholarship recipients pursuing higher Throughout this range of community education. activities, our chapter shares a close relationship with the Clark County Veterans Assistance Center .(CCVAC). Noteworthy is our financial assistance to the critically necessary relocation to a much-needed larger facility supporting local Veterans. And special recognition to MGen (Retired) Buck Marr who took a central role in making the relocation possible.


My physical contribution remains zero with my mobility still limited to a wheelchair and crutches while internal skeletal areas continue healing following extensive surgery. I remain optimistic that

physical therapy brings me closer to walking and driving in the New Year. Once again, I am reminded our organization self-sustains because of your diligent and dedicated voluntary efforts. None-the-less, the chapter needs both a larger orientation to include leadership focused on continued sustainment. This is not a unique CRC problem but rather recognized at MOAA's national level. While in recovery, I have participated in several Zoom meetings to discuss and share information. One initiative, likely to improve our recruitment, is that National is re-releasing membership information in the local area (our capture area) including the information on members who might have previously not wanted to share information locally.

Thanks to all for continuing to keep our charter ontarget to our mission! Enjoy the season, family and friends while continuing to look forward to chapter events in the New Year!

During our CRC September 14<sup>th</sup> BBQ and fund raiser **Lori Coffin** (left in photo below) of the Fort Vancouver Quilts of Valor presented a Quilt of Valor to **Amber Rosenberry** on behalf of her Dad, our Chapter President **Roger Rosenberry**. **Roger** at the time was hospitalized after a serious accident.



The evening of our BBQ Amber presented Quilt of Valor to him. See photo below. Here's what he shared with us in our September 2025 Newsletter, "My daughter, Amber, delivered the "Quilt of Valor" the evening of the BBQ. And it's been with me constantly since then. A tear in my eye. This beautifully handmade quilt is not for a caregiver but rather intended for those needing care. I never intended to be that person. Murphy's Law. I am humbled! Conversations are sparked constantly and a chance to tell our story."

The Mission of the Quilts of Valor® Foundation is to cover Service Members and Veterans touched by war with comforting and healing Quilts of Valor.

#### What is a Quilt of Valor?

A Quilt of Valor® (QOV) is a quality, handmade quilt that is machine or hand quilted. It is awarded to a Service Member or Veteran who has been touched by war. The Quilt says unequivocally, "Thank you for your service and sacrifice in serving our nation."

Lori Coffin's presentation September 14, 2025



Welcome to our ceremony. We are here to honor **Roger Rosenberry** for his service to our country.

**Roger** served with honor, performed his duties, and helped to ensure the freedom we have today.

The Quilts of Valor Foundation is a grassroots group of quilters from all across the US. In 2003, a quilter named **Catherine Roberts** had the idea of comforting veterans with quilts during the time her own son was deployed in Iraq. She described her situation then as being '10 seconds away from a panic attack 24 hours a day.

#### **Quilts of Valor continued**

One night she dreamed of a soldier on the edge of a bunk, wrapped in a quilt and her mission was clear to thank, comfort, and welcome home the service members and veterans who have so honorably served our country by wrapping them in beautiful handmade quilts...we like to say we are giving you a quilty hug.

Since 2003 over 422,000 Quilts of Valor have been awarded here in the United States, and in Germany, Iraq, and Afghanistan.

These quilts bring a three-part message from our hearts: honor, freedom, and comfort.

First, we HONOR you for your service to our country in the Military Services. We honor you for leaving all you hold dear to stand in harm's way in times of crisis, protecting us from the effects of war.

Next, we know that FREEDOM IS NOT FREE. The cost for our freedom is the dedication of lives of men and women like you, and this quilt is meant to say "Thank you" for your sacrifice.

And finally, this quilt is meant to offer COMFORT to you, and to remind you that although your family and friends cannot be with you at all times, you are forever in all of our thoughts and our hearts.

The founder of Quilts of Valor describes these quilts as the civilian equivalent of a Purple Heart. The quilts are awarded, not just handed out. The Quilt of Valor says, "thank you" for your service, sacrifice, and valor in serving our nation.



#### This is NOT a charity quilt. It is NOT a blanket.



A quilt has three layers, held together by stitches. Think of the layers in this way:

- The top of the quilt with its multitude of colors, shapes, and fabrics represents our many individuals and communities.
- The batting, the filler, is the center of the quilt, its warmth. It represents the hope that this quilt will bring warmth, comfort, and peace to the individual who receives it.
- The backing is the strength that supports the other layers. It represents the strength of the recipients, the support of their families, our communities, and our nation.
- Each stitch that holds the layers together represents love, gratitude, and sometimes the tears of the maker.

# Columbia River MOAA Foundation (CRMF) Fall 2025 Update by Dave Casteel CRMF President

Can't believe it is already December! Christmas decorations and the trees are already going up. Before we know it, we will be ringing in 2026!

The end of the year also brings the end of the 2025 tax season. If you haven't taken all of your RMD, do it soon so you don't get hit with a penalty from our friends at the IRS. One great way to do this is by designating a 501(c)3 charity (like the CRMF) as a recipient of a Qualified Charitable Distribution (QCD). Doing this not only benefits the charity, but also reduces your AGI dollar for dollar on the front side of your IRS form 1040 by the amount of your QCD\*. Don't delay, some financial firms take up to three weeks to process and deliver your request. Simply make the QCD payable to: Columbia River MOAA Foundation (CRMF) and mail it to same at our PO Box 1872, Vancouver, WA 98668. It's that easy! If you have specific instructions how you want it applied, please contact Frank and/or me (see front page of newsletter for contact information) and we will make it happen. What could be easier?

In November, we supported the Clark County Veterans Assistance Center with a \$500 check. President **Judy Russel** gave four of us (**Toby, Jim, Frank and me**) a tour of their very impressive new 10,000+ sq ft facility at 907 Harney St in Vancouver (across the street from the FISH food pantry). With the new facility (over double the size of their old location), comes new needs and expenses. Of course, they always need volunteers (parking is now easy and free)!

By the time you read this, you will have met some of our scholarship recipients if you attended the December 7th dinner at the Old Spaghetti Factory (OSF). Recipients from WSU-V: daughter of a veteran, **Maddie Clarke**, and from Clark College: veteran **Demi Wirewire**. **Mason Gibson**, while still a full-time Clark student, has moved out of the state and is not able to attend due to being on reserve military orders.

In other recent activity, Frank, Jim and I delivered a \$500 VISA gift card to the VA transplant Lodge (Bldg 18) to be used helping to provide meals to transplant or oncology veterans and their care givers over the holiday. We toured the building and were impressed with all the nice upgrades including new hospital beds in all the rooms as well as a full-size refrigerator in each room. The Lodge also has three spacious and well equipped common-use kitchens (one pictured is the dining area in front of the fireplace). We learned that auxiliaries from other veterans groups keep the kitchens stocked with water bottles and other kitchen incidentals including snacks.

# Columbia River MOAA Foundation (CRMF) 10<sup>th</sup> Anniversary Thank You

The end of 2025 marks ten full years since we formed the 501(c)3 Columbia River MOAA Foundation (CRMF). We formed it to better support veteranrelated needs in our greater community—and the good news is that we have succeeded!

Thanks to the generosity of our members, the CRMF has been able to donate nearly \$59,000 to Clark College and WSU-V for current use scholarships and endowment growth during this period. This means nearly 40 college students received MOAA scholarships from our Foundation.

We were the first organization to fund a scholarship at WSU-V in the 1980s. Back then, the \$600 scholarship went a lot farther when tuition was approximately \$2,000 per year (30% of a year's tuition)! Our scholarships increased to \$1,500 where it remained for many years. This year, we increased it to \$2,000. However, as you can imagine, tuition went up more quickly. It is now approximately \$10,300 per year. This means our scholarship now covers only about 19% of the tuition. With your support, it is our goal to increase the scholarship amount. To reach 30% of tuition costs, it would need to be raised to about \$3,100.

It's a different story at Clark College where we recently raised scholarships from \$1,000 to \$1,250. Current tuition for non veterans (i.e., children or spouses of veterans) is approximately \$3,500 a year (36% of tuition), and for veterans not receiving government agency tuition funds it is approximately \$2,650 a year (47% of tuition).

In addition, through our Support The Troops (STT) fund we have donated over \$30,000 to support numerous veteran-related needs in our greater community. The needs are still great and on-going, and we continue to search for ways to increase assistance to veterans in need.

Funds combined, your generosity has enabled our foundation to donate over \$89,000 to these needs and the year is not over. By year's end we will easily exceed \$90,000.

With your continued generosity, we look forward to busting through the \$100,000 mark before the end of 2026.
